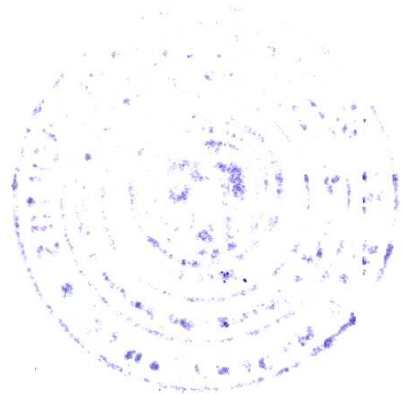



**1. NAME** : **SEVA BHARATHI**


**2. LOCATION** : #. 3-2-106, Nimboliadda, Kachiguda, Hyderabad-500027, T.S.

**3. AREA OF OPERATION** : Seva Bharathi will be carrying out its activities Primarily in the State of Telangana and also in other parts of the country (India) Depends up in the need of the circumstances.

**4. Aims and Objects** :


- i. In General, to serve the society as a whole in every manner without any distinction of caste, class or creed.
- ii. In General, to working every way for elimination of all types of social evils.
- iii. To inculcate and develop a spirit of service amongst our people.
- iv. To inculcate social consciousness and civic sense among people, to promote respect for work and labor, and to mould them into responsible citizens capable of discharging their social and filial obligations bearing in view our great heritage and culture.
- v. To promote self-reliance amongst the weaker sections of our people and an atmosphere of fraternity and mutual respect for all, and to take all necessary steps to eradicate social, evils like untouchability and dowry
- vi. To guide the weaker sections of gainfully employ their time and resources by setting up auxiliary earning opportunities like handicrafts; opening up new vocational avenues; creating marketing facilities and preventing exploitation by middlemen.
- vii. To work and organize for the proper implementation of the governmental and institutional plans and programs for the uplift of the weaker sections, so that the benefits reach the deserving.

- ix. 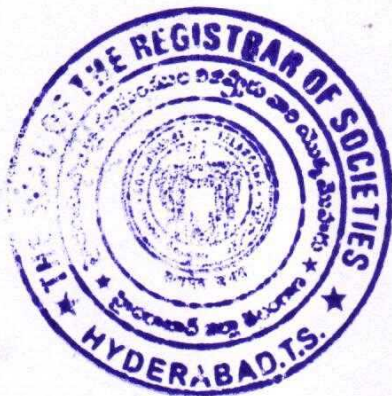

RULES AND REGULATIONS

NAME : SEVA BHARATHI

LOCATION : #. 3-2-106, Nimboliadda, Kachiguda, Hyderabad-500027, T.S.

ACTIVITIES:

1. The activities of Seva Bharathi shall be confined to the aims and objects set out in the Memorandum of Association
2. DEFINITIONS: In these Rules and Regulations unless the context otherwise requires:
  - i). General Body means all the members of the Seva Bharathi,
  - ii). Member means a member of the Seva Bharathi including Founder Member:
  - iii). Managing Committee includes the Managing Committee constituted under Clause 5(a) of the Memorandum of Association of the Seva Bharathi.

MEMBERS:

3. The signatures to the Memorandum of Association of Seva Bharathi shall be the Founder Members.
4. Membership of Seva Bharathi shall be only by nomination by the Managing Committee at its absolute discretion and shall be purely honorary. Any major person who subscribes to the ideals and activities of Seva Bharathi can apply for membership and may be nominated as a member. No membership fee is payable by the member.
5. A member shall cease to be so by resignation expulsion insolvency, insanity or death.
6. A member may resign by submitting a letter of resignation to the secretary and the resignation will be effective from the date of its acceptance by the Managing Committee.
7. A member other than a members of the Managing committee may be expelled from Seva Bharathi by the managing committee by Passing a resolution by 2/3rd majority of those present and voting at a meeting specially convened for that purpose that his continuance as such is undesirable and detrimental to the interest of Seva Bharathi.

#### GENERAL BODY:

8. The General Body shall meet at least once in a financial year (called as Annual General Meeting). The General meeting may be conducted either on physical mode (physical Meeting). Or Electronic Mode (E-meeting through phone or computer apps).
9. The secretary may convene the General Body by giving at least three clear days' notice of convene a meeting to all Members.
10. The president or one -third of the total Members may give notice to the secretary to convene a meeting of the General Body for any specific purpose and then the secretary shall convene the meeting within two weeks from the date of his receipt of knowledge of the notice.
11. The quorum for a meeting of the general body shall be 1/3<sup>rd</sup> of the total number of the members. In the case of E-meeting, confirmation from the presenter of the meeting about the participation of the members would be deemed as signed attendance of members present.
12. All questions arising for decision at the meeting of the general Body shall be decided at the meeting of those present, the president, the president of the meeting having a casting vote.
13. Subject to these rules and Regulations, the following matters shall be dealt with only by the General Body.
  - a). Election and removal of the members of the managing committee.
  - b). Adoption and approval of annual audited accounts.
  - c). Appointment of auditor for auditing the accounts of Seva Bharathi.

#### MANAGING COMMITTEE:

14.
  - a). The Managing committee shall consist of not less than seven Members and maximum of 15 members.
  - b). The Managing committee shall have the power to increase the number of its members as and when found necessary.
  - c). The members of the Managing committee shall be elected by the General Body for a term of three years, provided that the first elected members of the Managing Committee shall assume charge after the expiry of the term of the first Members of the Managing Committee under clause 5(b) of the Memorandum of Association.

15. A member of the Managing committee who ceases to be a Member shall automatically ceases to be a Member of the Managing Committee.

16. A Member may resign from the Managing Committee by submitting a letter of resignation to the Managing Committee and the resignation will be effective from the date of its acceptance by the remaining members managing committee.

17. A Member of the Managing Committee may be removed from the Managing committee by the general body by a resolution to that effect Passed by 2/3<sup>rd</sup> majority of those Present and Voting at a meeting Specially Convened for the Purpose.

18. Any Vacancy arising in the Managing Committee shall be filled by its remaining members by Co-opting from amongst the members. A nominated member of the Managing Committee shall retire along with the Other members of the Managing Committee.

#### MEETING OF THE MANAGING COMMITTEE:

19. The managing Committee shall meet at least once in every four months and as frequently as necessary. The meeting may be held either on physical Mode (Physical meeting) or Electronic mode (E-meeting through web apps).

20. The secretary may convene a meeting of the Managing committee at any time by giving at least 2 days clear notice to all its members. The Secretary shall convene a meeting of the Managing Committee at the request of any two of its Members within 15 days from the date of requisition giving 2 days clear notice to all its members. If the office of the secretary is vacant or the secretary fails to convene a meeting for any reason, any two members of the Managing Committee may convene its meeting in the like manner.

21. The quorum for a meeting of the Managing Committee shall be one third of total managing committee members or 3 (Three) whichever is more.

22. All decisions of the Managing Committee shall be resolved by majority of members present in the meeting. The Chairman of the Meeting will have a Casting Vote.

23. The Managing Committee may adopt a resolution by circulating the same to all its members.

#### OFFICE BEARERS OF THE SEVA BHARATHI:

24. There shall be (Seven) Office -bearers of the Seva Bharathi, i) President, ii) Vice President, iii) Secretary, iv) Joint Secretary, v) Organizing Secretary and vi) Treasurer. The number of office bearers which can be increased to maximum of 15 by adding additional office bearers for vice Presidents, joint Secretaries, Joint Treasurers. All the Officers are honorary and no remuneration is payable to any of the office bearers,

The President and the Secretary shall be elected by the members of the Managing committee from amongst themselves. The Vice Presidents, Joint Secretaries, the Organizing Secretary, Treasurer and Joint Treasurers, from amongst the remaining members of the Managing Committee. The election and nomination, as the case may be, of the office bearers shall take place immediately after the constitution of the new managing committee.

26. The office -bearers of Seva Bharathi shall hold office during their term as members of the Managing Committee.

**POWERS AND FUNCTION OF THE MANAGING COMMITTEE:**

27. The overall Management and Control of the Affairs of all the institutions of Seva Bharathi shall vest in the Managing committee subject to the supervision and guidance of the general body and in particular the Managing Committee shall have the power:

- a). To appoint staff, officers, management persons as may be required from time to time to carry on the activities of the society.
- b). Preparation and approval of annual budget
- c). To borrow money for activities of the society
- d). To acquire properties, both moveable and immoveable by gift or by way purchases, and

**POWERS AND FUNCTION OF THE PRESIDENT:**

28. The President shall be the head of Seva Bharathi and shall have all the advisory and supervisory powers as such. He shall preside over and conducts as President of the meetings of the General Body and of the Managing Committee ~~D. Venkateshwara Rao Secy.....~~

**POWER AND FUNCTIONS OF THE VICE PRESIDENT:**

29. The Vice President shall preside over and conduct as President the meetings of the General Body and of the Managing Committee and generally shall act in the place of the President during his absence and during the period, the office of the President is vacant.

**POWERS AND FUNCTION OF THE SECRETARY:**

30. The secretary shall be the chief executive of Seva Bharathi and shall have control over all the Employee and workers of Seva Bharathi, in particular, he shall

- a) Convene the meetings of the managing committee and the general body.
- b) Maintain regular and proper accounts of Seva Bharathi.

c). Prepare annual report and balance sheet of Seva Bharathi for each year and placed them before the managing committee for their consideration and the general body for approval.

d). Prepare the annual budget of Seva Bharathi and place the same before the managing committee.

e). Have the charge and control over all the properties and institutions of Seva Bharathi and shall be responsible to the managing committee.

f). Be entitled to sue or <sup>be</sup> sued in the name of the Seva Bharathi ; and

g) Have such other powers and function as may be entrusted to him specifically by the general body or the managing committee.

h). shall exercise his powers after the due consultation with the organizing secretary.

#### POWERS AND FUNCTIONS OF JOINT SECRETARIES:

31. The Joint Secretary shall assist the secretary and generally shall act in the place of the Secretary during his absence and during the period of the office of the secretary is vacant.

#### POWERS AND FUNCTIONS OF THE ORGANIZING SECRETARY;

32. The organizing secretary shall have collateral responsibility with the secretary and the joint secretaries who shall be assisted by the organizing Secretary in the matters of the Seva Bharathi

#### POWER AND FUNCTIONS OF THE TREASURER AND JOINT TREASURERS:

33. The Treasurer shall receive all moneys on behalf of Seva Bharathi and account of the same to the Secretary. He shall also make payments on half of Seva Bharathi as authorized by the Secretary.

The Joint Treasurers shall assist the Treasurer in its activities and one of the joint Treasurers to act as Treasurer in his office or when the office of the Treasurer becomes vacant.

#### 34. PROPERTIES AND FINANCE OF SEVA BHARATHI:

Seva Bharathi may collect or receive donations in cash or kind from individuals or associations for the purpose of carrying out the objects.

Seva Bharathi may acquire properties by lease, purchases, gift, mortgage, license or otherwise and sell, mortgage, gift, lease, mortgage or transfer in any other legal manner, properties belonging to Seva Bharathi for the purposes of achievement of its objects.

All moneys belonging to Seva Bharathi in the shape of fees, contributions, loans and advances or realized in any other manner shall form its finances.

36. All moneys belonging to Seva Bharathi shall be deposited in its name in one or more scheduled banks approved by a resolution of the managing committee and the account of Seva Bharathi in such one or more banks shall be operated jointly by any two of the three office bearers, namely the President, The Secretary and the Treasurer, However, the Managing committee can passing a resolution can authorize any other office bearer or employee (es) of the society for operations of the bank account by passing a resolution. The investments of the funds of the society shall be made in accordance with section 11(5) of Income Tax Act 1961.
37. The Accounts of the society shall be maintained on financial year basis and compulsorily shall be audited by a chartered accountant.
38. No member shall have any right to the properties or assets of the society.

39. AMENDMENTS :

No amendment or alteration shall be made in the objects of the association without prior approval of Commissioner of Income Tax (Exemptions and it is voted by 2/3<sup>rd</sup> of members presented at a second General Meeting convened for this purpose.

40. The Rules and Regulations of Seva Bharathi may be amended by the General Body by passing resolution proposed by the Managing Committee to that effect, by two-third majority of the members present at a meeting specially convened for the purpose.

41. BYE-LAWS:

The Managing Committee shall from time to time frame such bye-laws as may be necessary for carrying out the Aims and objects of Seva Bharathi and to implement these Rules and Regulations for the holding of the meetings, defining and clarifying the functions and powers of the office -bearers and other matters consistent with the memorandum of Association of Seva Bharathi and these Rules and Regulations. Such Bye-laws shall be placed before the next meeting of the General Body.

LEGAL PROCEEDINGS :

42. All Legal proceedings by against the Seva Bharathi shall be instituted in the name of Seva Bharathi through its Secretary.




**AFFILIATION :**

43. Seva Bharathi can give affiliation to or be affiliated to any institution or society, which is doing similar work and largely similar objects.

**DISSOLUTION/WINDING UP AND VESTING OF PROPERTY:**

44. The General Body has the right to dissolve Seva Bharathi at any time if not less than three Fifths of the members so determine at a meeting specially convened for the purpose.
45. In the case of dissolution/winding up any property or money what so ever Remaining after satisfaction of debts and liabilities of society shall be transferred /hand over to a society having similar aims and objects and also registered under section 12A or other application provisions of the income.
